# Key Information Document – Indices Spread Bet



### **Purpose**

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

### What is this product?

### Туре

This document relates to products known as 'spread bets'. A spread bet allows you to obtain an indirect exposure to an underlying asset such as a security, cash index or currency. This means you will never own the underlying asset, but you will make gains or suffer losses as a result of price movements in the underlying asset to which you have the indirect exposure.

This document provides key information on spread bet where the underlying investment option that you choose is a cash index e.g. UK100.

An investor has the choice to buy (or go "long") the Spread Bet to benefit from rising cash index prices; or to sell (or go "short") the Spread Bet to benefit from falling cash index prices. The price of the Spread Bet is derived from the price of the underlying cash index, which may be either the current ("cash") price or a forward ("future") price. For instance, if an investor is long UK100 Spread Bet, and the cash price of UK100 rises, the value of the Spread Bet will increase. At the end of the contract CIUK will pay the difference between the closing value of the contract and the opening value of the contract. Conversely, if an investor is long and the cash price of UK100 falls the value of the Spread Bet will decrease. At the end of the contract the investor will pay CIUK the difference between the closing value of the contract and the opening value of the contract. A SB referencing a futures price works in exactly the same way except that such contracts have a pre-defined expiry date – a date upon which the contract either automatically terminates or must be rolled into the next expiration period. The leverage embedded within all SBs has the effect of magnifying both profits and losses.

### Objectives

The objective of the spread bet is to allow an investor to gain leveraged exposure to the movement in the value of the underlying cash index (whether up or down), without actually needing to buy or sell the underlying cash index. The exposure is leveraged since the spread bet only requires a small proportion of the notional value of the contract to be put down upfront as initial margin and is one of the key features of spread bets. As an example, if an investor buys a UK100 spread bet worth £2 per point (each point being a change of 0.01 in the price) with an initial margin of 5% and an underlying buy price of 6500, the initial investment will be £650 (Trade Size x Price x Margin requirement as a % = (£2 / 0.01) x 6500 x 5%). The effect of the 20:1 leverage has resulted in a notional value of the contract of 13,000. This essentially means that each 1 point change in the price of the underlying, the value of the spread bet changes by £2 - i.e. a 1 point move in the direction of the client's trade means the client makes £2 and similarly a 1 point move against the client's trade means the client loses £2.


A spread bet on a cash index does not have a pre-defined expiry date. There is no recommended holding period and it is down to the discretion of each individual investor to determine the most appropriate holding period based on their own individual trading strategy and objectives.

Failure to deposit additional funds in order to meet the margin requirement as a result of negative price movement may result in the spread bet being auto-closed. Assuming that only one position is being open at the time on the account, this may occur when equity on the account reaches 50% of minimum margin required for this particular open position. Capital Index also retains the ability to unilaterally terminate any spread bet contract where it deems that the terms of the contract have been breached.

Spread bets are intended for investors who have knowledge of, or are experienced with, leveraged products. Investors should understand how the prices of spread bets are derived, the key concepts of margin and leverage and the fact that although Retail Clients may be subject to negative balance protection, they can still lose their entire investment. Professional clients' losses can exceed their deposits. Indeed, they will understand the risk/reward profile of the product compared to traditional share dealing. Investors will also have appropriate financial means and the ability to bear losses of the entire investment.

## What are the risks and what could I get in return?

**RiskIndicator** 



The summary risk indicator is a guide to the level of risk of these products compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified these products as 7 out of 7, which is the highest risk class. This is because there is a very high chance that you could lose all your investment, if you are a retail client.

Spread bets are leveraged products that, due to underlying market

movement, can generate losses rapidly. Losses can be up to the entire amount invested (if you are a retail client benefiting from negative balance protection). There is no capital protection against market risk, credit risk or liquidity risk.

# Even though Retail Clients are subject to negative balance protection, the total loss you may incur may include the entire amount invested.

Market conditions may mean that your spread bet trade is closed at a less favourable price, which could significantly impact how much you get back. We may close your open spread bet trade if you do not maintain the minimum margin that is required, if you are in debt to Capital Index, or if you contravene market regulations. This process maybe automated.

This product does not include any protection from future market performance so you could lose some or all of your initial investment if you are a retail client. If we are not able to pay what is owed to you, you could lose your entire investment. However, you may benefit from a consumer protection scheme (see the section, "What happens if Capital Index is unable to pay out?")

### **Performance scenarios**

The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other products. The scenarios presented are an estimate of future performance based on evidence from the past on how the value of this investment varies, and are not an exact indicator. What you get will vary depending on how the market performs and how long you hold the spread bet. The stress scenario shows what you might get back in extreme market circumstances. The following assumptions have been used to create the scenarios in Table 1:

The stress scenario above shows how small price movements can rapidly lead to significant losses, including losses greater than the initial margin requirement and can also result in a forced close out of your positions if you do not maintain the minimum margin requirements to keep your positions open. It is possible to lose the total balance on your account.

This does not take into account a situation where we are unable to pay you.

The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other products. The scenarios presented are an estimate of future performance and are not exact indicators. What you get will vary depending on how the market performs and how long you keep the investment.

The figures shown include all the costs of the product itself. The figures do not take into account your personal tax situation, which may also affect how much you get back. A Spread Bet is a leveraged financial derivative that follows the price of an underlying financial market.

A Spread Bet will make gains or incur losses as a result of price movements in the underlying asset. A Spread Bet will be quoted with a buy price and a sell price, with the difference being the spread fee.

Spreads will affect the returns of your investment. The price of a Spread Bet may be affected by factors such as inflation, interest rates, geopolitical events, government policy and economic factors.

What could affect my return positively?

A position that is taken at a buy price (going long) will make a profit if closed at a higher sell price.

A position that is taken at a sell price (going short) will make a profit if closed at a lower buy price.

What could affect my return negatively?

A position that is taken at a buy price (going long) will incur a loss if closed at a lower sell price.

A position that is taken at a sell price (going short) will incur a loss if closed at a higher buy price.

Severely adverse market conditions can negatively impact your positions. If your margin level is at or below the margin closeout level, we will close any or all of your open positions as quickly as possible. This may result in the loss of your entire account balance.

### What happens if Capital Index is unable to pay out?

If Capital Index is unable to meet its financial obligations to you, you may lose the value of your investment. Capital Index segregates all retail client funds from its own money in accordance with the UK FCA's Client Asset rules. Should segregation fail, your investment is covered by the UK's Financial Services Compensation Scheme (FSCS) which covers eligible investments up to £85,000 per person, per firm. ### What are the costs?

This table shows the different type of cost categories and their meaning.

		Spread	The difference between the buy price and the sell price is called the spread. This cost is realised each time you open and close a trade
	Daily Holding Costs (Swaps)	A fee is charged to your account for each night that your position is held. This means the longer you hold a position, the more it costs. The current swaps fee can be referenced within the trading platform in the symbol specification section.	

### How long should I hold it and can I take money out early?

Spreadbets are intended for short term trading, in some cases intraday and are generally not suitable for long term investments. There is no recommended holding period, no cancellation period and therefore no cancellation fees. You can open and close a spreadbet on a cash index at any time during market hours.

We may set a higher percentage than 50%.
